RESOLUTION NO. 2020-07**

**A Resolution of the Borough of Lemoyne, Cumberland County, for Placing  
Banners Across State Highways to Advertise Smoke in the Park in Memorial  
Park on September 25-26, 2020**

**WHEREAS**, the Borough of Lemoyne intends to erect banners (2) across state roads within the Borough, for the purpose of advertising the *Smoke in the Park* bar-b-q competition and other related events in Memorial Park on September 25-26, 2020; and

**WHEREAS**, the Pennsylvania Department of Transportation requires a Resolution passed by the governing body of the municipality to erect banners across state roads; and

**WHEREAS**, the banners will be suspended on existing permanently affixed cables strung across Market Street (SR1010) at Fifth Street, and across South Third Street (SR2035) at Walton Street, at a height of no less than 17'6" above the highway; and

**WHEREAS**, the banners will be advertising the Smoke in the Park bar-b-q competition in Memorial Park on September 25-26, 2020, and any corporate advertising on the banner will be less than 20% of the size of the banner; and

**WHEREAS**, the Borough of Lemoyne will assume full responsibility for maintaining the banner poles and for erecting, maintaining, and removal of the banners and, further, assumes all liability for damages occurring to any persons or property arising from any act or omission associated with the banners; and

**WHEREAS**, traffic control will be preformed in accordance with the most current Penn DOT Publication 213.

**NOW, THEREFORE, BE IT RESOLVED** by Borough Council of the Borough of Lemoyne that Resolution 2020-07 expresses the intent of Lemoyne Borough to erect banners across SR2010 and SR2035 according to conditions set by the Pennsylvania Department of Transportation, and permitting the organizations listed below to suspend a banner under the following conditions, is hereby approved:
