- WHEREAS, Lemoyne Borough understands that, by signing the Signature Page for Grant Application and Grant Agreement and submitting it to the Department as part of the grant application, Lemoyne Borough agrees to the terms and conditions of the grant and will be bound by the Grant Agreement if the Department awards a grant.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED that:

- 1. The Signature Page for Grant Application and Agreement may be signed on behalf of Lemoyne Borough by the official who, at the time of signing, has the title of Borough Manager; and
- 2. If the Borough Manager signed the *Signature Page for Grant Application and Grant Agreement* prior to the passage of this Resolution, this grant of authority applies retroactively to the date of signing; and
- 3. If Lemoyne Borough is awarded a grant, the *Signature Page for Grant Application and Grant Agreement*, signed by the Borough Manager, will become the Borough's executed signature page for the Grant Agreement, and the Borough will be bound by the Grant Agreement; and

4.	Any amendment to the Grant Agreement may be signed on behalf of Lemoyne Borough by the
	official how, at the time of signing of the amendment has the title of Borough Manager and
	Lemoyne Borough will be bound by the amendment.
