Routine Maintenance / Events

- Biosolids being hauled as generated to Cumberland County Landfill.
- Process control adjustments as required.
- Sampling and Lab Analysis.
- Daily operations ongoing including inspections, cleaning, testing and chemical replenishment.
- Ongoing completion of preventative maintenance schedule.
- Continue to implement NPDES (National Pollution Discharge Elimination System) permit.

Non-Routine Maintenance / Events

- Working with Mike Knouse on CIP information.
- Plant equipment maintenance.
- Monitoring changes made to control nutrient removal.
- Semi-Annual calibrations completed by Control Systems 21 on 4/21/21.
- Annual Form 43 completed on 4/13/21. Biosolids testing for Cumberland County Landfill.
- Additional lab testing for NPDES permit renewal.
- Working with RETTEW on UV System Design.
- Locating utilities in area of UV System.

Collection System

- Ongoing preventative maintenance on trouble spots. (solids, grit, grease, problem areas)
- Working on yearly routine flushing. Around 32,000 feet cleaned so far.

WWTP Personnel Info, Classes, Accomplishments

- Kyle Janny passed his CDL road test on 7/29/2021.
- Kyle Janny passed HACC Wastewater Operator class, and all DEP tests for Operator License.
- All plant personnel attended PA 1 Call training on 4/21/21.
- PA 1 Call recognized Lemoyne WWTP personnel on having a 100% response rate.
- Bob Oakes took a Valves- Operation and Maintenance class worth 15 hours towards licenses.
- All plant personnel reviewed our EAP (Emergency Action Plan), and our SPCC/PPC (Spill Prevention, Control & Countermeasures / Preparedness, Prevention & Contingency) plan.

Pending Issues

- Grit system not functioning properly due to being oversized. Not enough flow or velocity to work correctly.
- Digester diffusers continue to clog. Would like to replace with a non-clog diffuser like Relia Ball or similar.
- Second stage oxic tanks are not getting the amount of mixing needed since lowering the amount of air to the tanks to meet our nutrient requirements.
