

COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE

March 9, 2023

1. The meeting of the **COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE** was called to order at 6:14PM by Sue Yenchko, Chair. In attendance were Sue Yenchko, Rebecca Coleman, Lisa Kelly* Cliff Karlson* and Jenn Erickson*.
2. **Public Comment** – There was no public comment.
3. **Minutes** of the February 9, 2023 meeting were presented. On a Coleman/Yenchko motion, the minutes were approved.
4. **Old Business** –
 - A. **Pennsylvania Girl's Rugby** – Lisa Kelly, the Central Region Coordinator Requested use of Memorial Park for practices on Mondays or Tuesdays, April 17th through June 11th, and again next fall from mid-September through October 31st. There will be only 2 Sunday games played in Lemoyne (at 5:30 – 7:15). Older girls will use the baseball field and younger girls will use the space near the pavilion. 40 girls participate on game days. They have 12-girl teams in New Cumberland, Camp Hill, Dillsburg and here. They do running and conditioning and they clean the park up after they play. On a Coleman/Yenchko motion Use of the Park was OK'd.
 - B. **Messiah University Public Arts Course** – Sue Yenchko gave on an update on the progress of the mural panels which will be affixed to the borough's wall outside of the community room with the installation date being March 16th. The panels will be anchored by a "French cleat" method. An application of "anti-graffiti" coating will be recommended to Mr. Finch. The borough is very grateful to the Messiah Art Class (Community Art) for producing these colorful and beautiful works.
 - C. **Comprehensive Recreation, Park and Open Space Plan Work Plan (CRPOS)** – Rebecca Coleman gave an update on the Plan. There is continuing work on getting all of the edits addressed and including the parts that were left out. There's an April deadline for C2P2 grants which will be submitted for Memorial Park improvements. The county grant will have the time extended to comply as a C2P2 match. A study Committee meeting will be held to get everyone on the same pages with all the necessary changes.
 - D. **Susquehannock Dig Artifacts: Display Details** – S. Yenchko – The display case is ready with all elements. PHMC provided a disc which shows all of the items that will be on display but no groupings. We still need the groupings to set up the display case.
 - E. **River Spirit Sculpture Placement** – No update
