

COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE

June 9, 2022

1. The meeting of the **COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE** was called to order at 6:02 PM by Sue Yenchko, Chair. In attendance were Kasha Griva, Rebecca Coleman*, Rebecca Yearick, Judy McAlister, Ed Dix*, John Leverentz, Cindy Foster, (*on Zoom).
2. **Public Comment** – There was none.
3. **Minutes** of the May 12, 2022 meeting were approved unanimously following a Griva/ Yenchko motion.
4. **Old Business** –
 - A. **Comprehensive Recreation, Park and Open Space Plan Work Plan (CRPOS)** –There was no May meeting of the CRPOS Study Committee so the June meeting will be on June 23rd at 5pm in Memorial Park. There will also be a walk-through at Memorial Park on June 24th with a DCED representative and a forester and anyone can join the walk-through. Lori Yeich from DCNR who works on comprehensive plans noted that the next grant round starts in January 2023. The CRPOS Study Group expects the “Plan” to be done by fall. The county grant period begins in June 2022. Our first funding requirement may be for Memorial Park for a more in-depth Master Plan.
 - B. **Susquehannock Dig Artifacts: Next Step for Loan?** Examples of artifacts that can be displayed were shown and after discussion, it was noted that a guide sheet needs to accompany the artifacts displayed. A QR code could also serve this purpose.
 - C. **The Lemoyne Passage Mural** – There was nothing new to report on the status of the mural.
 - D. **Flag Rugby Proposal** –Lisa Kelly sent a note that they are struggling to get West Shore girls signed up for Flag Rugby. She is interested in setting up a table both at National Night Out in August and at the Concert at Negley to market this program.
 - E. **Market the Borough as a Livable Community (Strategic Plan)** – On hold.
 - F. **LogoWear Proposals (T-Shirts)** – After reviewing three vendors to provide the shirts for sale, we will contact Rehoboth T-Shirts and Signs to produce the shirts. They are needed by July 2nd for sale at the Concert at Negley.
 - G. **Council Room Logo** – Having the Lemoyne Logo on the back wall in the council chamber lead to discussion of following Kari Hultman’s recommendations to use a white rectangle with the logo on it instead of painting it directly on the wall.
