

## COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE

### MEETING on January 10, 2019 - MINUTES

1. The meeting of the **COMMUNITY DEVELOPMENT/PARKS AND RECREATION COMMITTEE** was called to order at 6:04 PM by Sue Yenchko, Chair. In attendance were Kasha Griva, Rebecca Yearick, and Cindy Foster, Borough Manager and Robert Huggler.
2. There was no public comment.
3. The **minutes of the November 8th meeting were unanimously approved** on a Griva/Yenchko motion.
4. Update on the **revised Community Survey** – The 2019 budget has allocated up to \$5K for the survey. Ms. Foster updated the committee on her meeting with the PA Economy League (PEL) which will be working on Lemoyne's EIP during 2019. The PEL proposed postponing the survey until Phase 2 (2020) of the EIP where additional funds could be applied for. After discussion that we'd like to get a sense of what issues Lemoyne citizens have top of mind, but not do the visioning part of the process, we will pause going ahead with the survey until there is a further discussion with PEL.
5. **PA Historic Marker/National Register of Historic Places effort (re: archeological dig)** –Ms. Griva and Ms. Yenchko visited with the senior archeologist, Kurt Carr, of the PA Historic and Museum Commission who gave a tour of the archeology section of the museum and displayed some of the artifacts recovered from the Lemoyne dig. He urged our applying for Historic Marker designation which Ms. Griva will pursue. The committee is interested in getting some of Lemoyne's historical sites "on the map". We will also be looking at National Register designation for the Susquehannock site as well as the Overland Tpk. which runs parallel to the park. Ms. Yenchko will research whether such a designation would restrict a future, potential dig on the Lemoyne portion of the property.
6. **Aesthetic Overlay proposal** – Ms. Yearick stressed that the municipality decides what should be in the overlay. She noted that Camp Hill's overlay is now known as the "downtown" district. She will provide us with some examples from other municipalities.
7. **Library Donation – Wording on Paver** – The committee voted unanimously to forward the following to Council and the library: **LEMOYNE (LOGO)...**/The Little Town That/ Has It All/ Welcomes You! / 2019
8. **Parks Issues?** There were no parks issues.
9. **Other Business** - Question was asked – What is happening with "Bike Share"? There might be more information at the next Council meeting

There was also discussion about a potential residential development of 55+ affordable housing on 12<sup>th</sup> Street below the Artis building.
