# Cumberland County EMS Council Paramedic Rex Carmichael EMS Scholarship Program

### Introduction:

The Cumberland County EMS Council is blessed and honored, on behalf of member EMS agencies and those who benefit from emergency medical services in the course of living, working, or visiting Cumberland County, to receive private donations for the purpose of creating and maintaining an EMS Scholarship Program.

At the request of the principle and inaugural donor, this scholarship program is named in honor of Paramedic Rex Carmichael, a Cumberland County native and lifelong resident, who has served our communities for decades in a variety of public safety roles.

Scholarship funds are awarded in a manner developed and approved by the representatives of Cumberland County EMS Council member agencies, with the sole purpose of assisting individuals with tuition and possibly other costs incurred in the course of obtaining training and securing EMS provider certification in the Commonwealth of Pennsylvania, and then serving Cumberland County communities in that role.

The scholarship fund is evaluated annually by the Scholarship Committee. Recommendations for annual awarding allotment are made to and approved by the EMS Council. Applications are reviewed in the order in which they are received.

### Eligibility and awarding parameters:

At the time of application, time of awarding, completion of the applicable training program, AND receipt of the applicable EMS certification credential, a candidate must meet the following scholarship eligibility criteria:

- Be a resident of Cumberland County OR be affiliated as a member in good standing, in either a volunteer or paid capacity, with an EMS agency or fire department with first-due 911 service area in Cumberland County.
- Candidates who are selected will receive awarded funds in the following scholarship/reimbursement amount and schedule:
  - 50% of the award will be paid by Cumberland County EMS Council, on behalf of the awardee, at the time of the awardee's registration in the training program, directly to the selected EMS Training Institute.
    - IF registration/tuition has already been paid by the awardee, as verified by receipt of payment, the scholarship amount will be paid as a reimbursement directly to the awardee.
    - The awardee must register, pay the balance due to the EMS Training Institute, and then begin and complete their EMS certification training program.
  - The remaining 50% of the award will be reimbursed to the awardee upon successful completion of the training program AND receipt of Commonwealth of Pennsylvania certification.
    - Reimbursement will be processed upon EMS Council's receipt of the awardee's paid registration/tuition receipts and a copy of their Commonwealth of Pennsylvania EMS certification.

### Scholarship amounts and schedule:

Total Scholarship/reimbursement amounts according to pursued training/certification level:

- Emergency Medical Technician (EMT) \$1,000.
- Advanced Emergency Medical Technician (AEMT) \$1,250.
- Paramedic \$1,500.

ALL candidates, regardless of the EMS certification pursued, are subject to the following timeline:

- Application period is February 1, 2024 April 30, 2024.
- Scholarship awarding will be determined and the candidates will be notified no later than May 31, 2024.
- The applicable EMS training/certification program must begin between <u>July 1, 2024 and December 31, 2024.</u>
