## Lemoyne Municipal Authority Regular Business Meeting Minutes – Tuesday, September 13, 2022

Present: Chairman John Carroll, Vice Chairman Pete Shuntich, Treasurer Will Hesse, Assistant Treasurer Dennis McGee, Secretary Steve Spangler, Wastewater Superintendent Bob Oakes, Engineer Mike Knouse, Solicitor Lisa Coyne, and Borough Council Member Gene Koontz.

The meeting was called to order by Chairman John Carroll at 6:00 pm.

Dennis McGee made a motion to approve the August 2022 minutes. Pete Shuntich 2<sup>nd</sup> the motion. Motion passed.

**Citizens and visitors:** Gene Koontz said that the budget meetings will be held next month, and the sewer budget date is October 12<sup>th</sup>. Discussed the policy to hook up party lines or shared laterals. Details have to be worked out where if the borough does the work and they can put a lien on the property so they can recoup the monies invested in the property.

**Operators' Report:** (attached) Phosphorous has been corrected. Secondary digester diffusers have been installed. North side pump station had the pulleys changed to speed up the pump, so it works more efficiently. The internal PH has been raised to 6. Bought a trailer to house the camera and tv equipment. This is in place of the budgeted truck that Ford couldn't promise a delivery date on and kept raising the price \$15,000 over the initial quote. The trailer will be outfitted with climate controls and be stored inside. Another plus is that they can hook up to any of the trucks.

Pete Shuntich made a motion to accept the Operators' Report. Dennis McGee seconded. Motion passed.

**Engineers' Report:** UV report was submitted, reviewed and approved. Borough has received a land development for Taco Bell. Construction plans to be reviewed next meeting.

Motion to approve the Engineers' Report was made by Pete Shuntich, seconded by Will Hesse. Motion passed.

**Treasurers' Report:** (attached) Motion to accept the Treasurers' Report was made by Dennis, seconded by Pete Shuntich. Motion passed.

**Payment of the Bills:** (attached) Will Hesse abstained from this vote as his employer is listed. Motion by Steve Spangler to accept the Payment of the Bills, seconded by Dennis McGee. Motion passed.

**Solicitors' Report:** No report as there was no action on items.

**Old Business:** The audit will be reviewed at the October meeting.

**Adjournment:** There was a motion to adjourn from Dennis McGee, seconded by Pete Shuntich.
