Tuesday November 10, 2020 Municipal Authority Meeting

#### 1. Call to Order

The Authority met in regular session at 6:08 p.m. over Zoom. Authority members John Carroll, Pete Shuntich, and Will Hesse were present, along with the Authority engineer Mike Knouse and Solicitors Lisa and Robert Coyne. The Plant Manager, Councilmen Gene Koontz, and residents Steve Spangler and Bob Huggler were also in attendance.

#### 2. Approval of Minutes

Pete Shuntich made a motion to approve the minutes from the October 13 meeting. Will Hesse seconded the motion. The minutes were approved.

#### 3. Citizens and Visitors

Councilmen Gene Koontz discussed the Borough's sewer bill credit policy that was adopted in October, which provides relief to residents for outdoor uses of water. The credit must be requested by the resident, and it will involve reviewing the previous 12 months of water usage. Resident bills which were greater than 3x the 12 month average would see a once per calendar year relief.

Additionally, Councilmen Koontz stated that the Borough Council was postponing the scheduled 2021 rate increase until 2022, based on the recent budget meetings and Sewer Fund Balances. Councilmen Koontz requested a Capital Improvement Plan for the next 3-10 years.

#### 4. Operator's Report

The Operator submitted his report. The Operator reported that the Clark and Walton Pump Stations are online and operational. The Contractor has a few cleanup items and landscaping work to complete.

#### 5. Engineer's Report

### Clark and Walton Pump Stations

The pump station startup was successful and a punch list is being generated. The mechanical contractor has submitted AFP #2, and electrical contractor has submitted AFP #1, for payment. The Engineer is recommending payment of the two Application For Payment requests, with 10% retainage still being withheld.

## **WWTP Incoming Flow Study**

The Engineer submitted the results of the flow study. The flow data, along with potential connects equaling 500 EDUs, supports the idea of derating the WWTP. The permitted plant capacity would be reduced to a hourly rate of 3.0 MGD and max monthly less than or equal to 1.0 MGD. The consideration of moving forward will have impacts on the NPDES Permit and future WWTP equipment purchases.

Pete Shuntich made a motion to receive and accept the Engineer's report. Will Hesse seconded the motion. The motion passed unanimously.

### 6. Treasurer's Report

The estimated Debt balance as of November 1, 2020 is \$14,807,319.74.

Will Hesse suggested closing the First National Bank Operating Account. This account is no longer necessary, since the debt refinancing. Pete Shuntich made a motion to close the First National Bank account. John Carroll seconded the motion. The motion passed unanimously.
