Minutes for the Meeting Held on September 14, 2015 at 7:00PM

1. Call to Order

A meeting of the Parks and Recreation Committee of the Lemoyne Borough Council was held on Monday, September 14, 2015 at the Lemoyne Borough Hall, 510 Herman Avenue, Lemoyne, PA. The meeting was called to order by Chairperson Donna Hope at 7:00PM.

2. Roll Call

Present at roll call were committee members Brenda Candioto and Dave Beasley. Staff members present were Robert Ihlein, Borough Manager, Todd Miller, West Shore Recreation Aquatic Program Director, Jim Fair, Maintenance Supervisor and Karen Unger, Executive Assistant.

3. Public Comments

Resident Patty Beasley wanted to know why there were no Halloween parties sponsored by the Borough. Ms. Hope will go to Mayor York to discuss the possibility of having this and other holiday events.

4. Review of the minutes from the previous meeting

Mrs. Candioto made a motion to approve the minutes of the July 13, 2015 meeting with corrections. Motion was seconded and unanimously approved.

5. Unfinished Business

A. Items/help needed for the Smoke in the Park event

Mr. Fair reported that the electrical breakers need to be checked to make sure there is sufficient electrical service for the event. Additional temporary lighting is being provided. Extra sanitary equipment has also been ordered.

6. New Business

A. Update on the pool season

Mr. Miller reported there was a total of 664 memberships purchased this season. Lemoyne residents made up 52% of the total memberships. There was also an increase in walk-in business from last year. Harrisburg Academy brought in more business than the previous year. There were also a number of days where the pool reached capacity.
