1. Call to Order

2. Roll Call

3. Public Comments

4. Review of the Minutes from January 19, 2017 meeting
Minutes were approved without any negative votes.
5. Subcommittee and other reports
 - a. Report from Design Subcommittee
The sponsors for the Mural Project attended a presentation by the Cumberland Valley Visitors Bureau to formally receive the \$25,000 grant. The project has received nearly \$100,000 to this point.
 - b. Report from Lemoyne Business Association – Gale Gallo
No report was given.
 - c. Report from Downtown Services Coordinator – Rebecca Yearick
Ms. Yearick gave her report. A new Vietnamese restaurant has opened on 10th street. Chris and Val's café will become Valerie's Café. The former Lemoyne Middle School property is under agreement with the Cumberland County Real Estate Collaborative (REC) for \$450,000.

 - c. Park – Portable Toilets

We received two quotes. Walters increased their fee to \$26 per month. We typically rent 4 per month. We received another quote from Associated Products for \$35 per month. We will most likely go with Walters.

d. Ash Tree Removal

We have to get quotes on four trees that are too high for our staff to take down themselves. Jim Fair will let the county conservation district know that we have been having a problem with the emerald ash bore.

e. Park Grant

Jim Fair has been in contact with DCNR for a grant for playground equipment that we be placed at Flynn Park. As much as \$20,000 can come from the grant. The Borough must apply April 23, 2017 with all of the plans. The awards will be announced in December 2017. Potential groundbreaking is 2018.

f. Electronics Recycling

The county has begun to look at an electronics recycling. The borough may decide to join with the county to help Lemoyne residents recycle their electronics without having to go to Carlisle.
