Minutes
May 15, 2017

1. Call to Order

The meeting was called to order at 6:00 p.m.

2. Roll Call

Dan Green, Mike Sadowski, and Chairwoman Donna Hope were in attendance.

3. Public Comment—None

4. Review of the Minutes from April 17, 2017 meeting

The minutes were approved.

5. Pool Opening

Todd Miller provided an update noting the pool will be opening May 27. There will be staff training Monday, May 22.

6. Subcommittee and other reports

a. Report from Design Subcommittee

Ms. Yenchko stated that painting of the mural should be completed by the end of June. This is two months ahead of schedule. The Cumberland Valley Visitors Bureau sent seven people out to paint the mural and donated \$25,000 to the cost of the project. Penn DOT has signed off on the right-of-entry agreement.

b. Report from Lemoyne Business Association – Gale Gallo

c. Report from Downtown Services Coordinator – Rebecca Yearick

Ms. Yearick gave her report that was identical to the one given at the May Council meeting.

7. New business

b. Update – Parks

We received the application for Smoke in the Park. Dan Green made a motion to recommend that Council approve Smoke in the Park at no cost to the West Shore Bureau of Fire. The motion was seconded by Donna Hope. The motion passed unanimously.

Mr. Fair mentioned that Carpenters Cup League would like to use the Negley Park ball field on June 7. The Mid-Penn Suns would be using the field. Fees have been waived.

c. Needs - Donation from Lion's Club

The West Shore Lions Club is looking to donate something to the Borough.
Mr. Fair will be getting prices for metal benches to be installed at Flynn Park.

d. Mrs. Spilewski provided a list of questions resulting in the following responses:

- i. Non-residents that own property in the Borough will continue to pay the non-resident rate for facility rental.
- ii. Schools and churches will not receive the resident rate for pavilion rentals if they're not located in the Borough.
- iii. Members of the West Shore Bureau of Fire and West Shore Regional Police will receive half-priced pool passes regardless of their residence.
- iv. Borough employees will not be permitted to purchase pool passes for extended family members for half price.
- v. The Borough will allow full-day and half-day rentals of the community room for for-profit entities. The deposit will remain the same.
- vi. The Borough will continue to offer family passes by resident address.
- vii. The Borough will continue to allow hourly rentals at Memorial Park.
