Streets Committee

Minutes of the Meeting Held on April 13, 2016 at 5:00PM

1. Call to Order

A meeting of the Streets Committee of the Lemoyne Borough Council was held on Wednesday, April 13, 2016 at the Lemoyne Borough Hall, 510 Herman Avenue, Lemoyne, PA. The meeting was called to order by committee chairperson Bob Huggler at 5:00PM.

2. Roll Call

Committee members present were David Beasley and Dennis McGee. Staff members present were Robert Ihlein, Borough Manager, James Fair, Borough Maintenance Supervisor, Mike Knouse, Borough Engineer, and Karen Unger, Executive Assistant.

3. Public Comments

Resident Audra Spilewski asked about the parking on Ayers Avenue. Mr. Fair stated that Council would need to make an ordinance for the change of parking direction. This is being passed on to the Ordinance and Zoning Committee for further review and action.

4. Review of the minutes of the previous meeting

Mr. McGee made a motion to approve the minutes from the March 9, 2016 meeting minutes as written. The motion was seconded and unanimously approved.

5. Unfinished Business

A. Traffic Signals on Lowther Street

Mr. Ihlein, Mr. Knouse and Mr. Fair had a meeting with PennDOT. Copies of the meeting minutes were provided. There was discussion on who owns the traffic lights. The Borough did not sign off on the lights as PennDOT claims.

The recommended changes to the Lowther Street intersection was not a budgeted item. Liquid fuels monies could offset the cost of this change Mr. McGee made a motion to send this issue to Council for review and approval. The motion was seconded and unanimously approved.
